## **NOTIFICATION**

This is to inform all concerned that the High-Fee category seats will be offered to interested candidates on the same day as the Counselling-cum-Admission of the respective programmes, as per the merit lists already published on <a href="https://awu.ac.in">https://awu.ac.in</a>, and in accordance with the earlier notification vide No. AWU/Acad/20/2020/967 dated 23<sup>rd</sup> July 2025. Admission for High Fee category of each Programme will commence immediately after completion of the admission of regular seats on the same day of Counselling-cum-Admission.

Interested candidates are hereby requested to approach the concerned department immediately after the completion of the admission of regular seats. All waited listed candidates who have not been admitted in any regular seat are eligible for High-Fee category seats and their admission will be as per the University Norms.

The fee structure for High-Fee category seats is as follows:

- BPT Programme: ₹47,025.00 (Rupees Forty-Seven Thousand Twenty-Five only) payable for the 1<sup>st</sup> semester only. From the next semester onwards, the fees will be the same as those for Regular category seats.
- All PG Programmes: ₹48,566.00 (Rupees Forty-Eight Thousand Five Hundred Sixty-Six only) payable for the 1<sup>st</sup> semester. From the next semester onwards, the fees will be at par with Regular seats.

**N.B.**: Candidates whose names are in the Merit List must report for Admission strictly adhering to the Reporting Time as mentioned in the earlier notification vide No. AWU/Acad/20/2020/967 dated 23<sup>rd</sup> July 2025 i.e. between 9:30 am to 10:00 am, otherwise their seat will be forfeited.
